- (1) This MOU shall enter into force on the date of signing.
- (2) This MOU shall remain in force for a period of 03 years (Three years from 07th July 2021 to 06th July 2024) and may be extended for another period of 03 years (Three years) by mutual written consent of both the Parties.
- (3) Either Party may terminate this MOU at any time by giving written notification to the other Party on its intention to terminate this MOU, 06 Months (Six months) prior to the date of the termination.
- (4) The termination of this MOU shall not affect the completion of any projects and programs in Progress and not completed at the time of termination.
